VIII. ESP Report / Directors Report

ESP Report (Superintendent Isaiah Pettway)

State Budget Update

- The state passed its budget, avoiding a major government shutdown.
- The per-pupil allowance increased from \$9,600 to \$10,060—the largest increase in three years.
- The food program remains whole, allowing meal service for all students to continue.

Federal Budget Update

- Reductions in the U.S. Department of Education's Special Education Division may affect IEPs, planning for them, approvals, and IDEA funding. IDEA is the Individuals with Disabilities Education Act (grant) which offsets the cost of these services. The impact is still unclear and will be monitored closely.
- School enrollment is at 112 versus our goal of 105. All students have been counted.

- Additional morning security is needed due to higher AM attendance and we are looking into that.
- The school is seeking a part-time Special Education Teacher to support the increased number of students with special needs.
- There will be an amendment to your budget (probably) in December.

Director Report (Mrs. Shelly Smith):

Enrollment Update

- Enrollment increased from 93 students in early September to 112 by Count Day, with most in 9th and 10th grades.
- Applications are still being accepted, and interviews will resume in November.
- Two students were absent on Count Day but were verified by Day 3.

Student Progress

- Students earned twice the expected monthly credits; only two earned zero.
- September attendance averaged 91%.
- Parents have shared improved student attitudes and desire to come to school.
- Staff are required to make at least two positive calls per year to each family; calls have begun, focusing on new parents.

2. 2025 Audit Update

Sherry is working with the auditor to meet the November 1 deadline; the audit is on track and will be submitted on time. Preliminary results show improvement, with the deficit reduced from \$95,000 to \$25,000—a \$70,000 decrease. The academy is expected to fully eliminate the deficit this year and that was the goal. The final audit will be on next month's agenda, and the auditor will present findings to the board. Board members will receive an audit-related questionnaire via email, so be on the lookout.
