A. Discussion Items
Superintendent's Report-Jennifer Hernandez
Julie Hopper from LSSU assisted Jennifer with sharing the academy's academic goals. Jennifer discussed the growth in Reading and Math on the M-Step, PSAT and SAT. Jennifer also mentioned that HERO is based on the common core standard that aligns with the district's benchmark assessment Performance Series. For the academy specific goal there were 38 graduates and 12 students within 1 credit of meeting the goal. Superintendent Jennifer Hernandez mentioned that Way Academy of Flint would have a buzzer and a security camera installed in the near future. Jennifer also mentioned that there was a Washtenaw student that graduated from Way Michigan.

1. Director's Report-Scott Henwood Mr. Henwood mentioned that we had 13 graduates for the December 18, 2018 graduation. Mr. Henwood also mentioned that parents thanked the staff for all of their efforts to help their child to be successful and graduate. We have one student who graduated and will participate in the June graduation. Scott reported out on enrollment trends. Credit attainment was discussed, students need .5 credits each month. Student attendance in October was good. Mr. Henwood noticed that attendance has dropped due to the winter break. Board President Buctow asked if the low attendance rate was for lab or online. Mr. Henwood stated that it was both lab and online attendance. Howard attended graduation and was very pleased and mentioned all students were planning on attending college and 1 student was going into the workforce.

- Academic Goals and Progress Report-Jennifer Hernandez Superintendent Hernandez discussed Performance Series testing and academic goals. Core students must out perform non-core students in order to be successful.
- 3. November 2018 Financial Reports-Kelli Glenn Kelli Glen shared this information with the board and provided them with a financial handout. Melissa Weisberger (LSSU) mentioned funding that would be disbursed to the school. Kelli stated that monthly funding would be \$35,000 for the month. In closing, Kelli also mentioned the budget amendment to the Board and to adjust risk funds the next amendment. President Buetow mentioned lower enrollment and wanted to know if this was a concern. Kelli mentioned the cash on hand would meet the monthly obligation.
